Announcement of Suranaree University of Technology on the English Language Assessment for Undergraduate Students of Suranaree University of Technology, B.E. 2565

In order to support and foster students of Suranaree University of Technology (SUT) to acquire knowledge, competence, and performance of English language for practical use for academic, occupation, and communication purposes and to abide by the Announcement of Office of the Higher Education Commission on the Policy of Upgrading the English Language Standard of Students in Higher Education Institutions, dated 12 April B.E. 2559, SUT deems it appropriate to establish the announcement.

By virtue of Section 21 and Section 24 of the Suranaree University of Technology Act B. E. 2533, Announcement of the Office of the Prime Minister on Appointment of Rector of Suranaree University of Technology, dated 14 September B. E. 2564, and the resolution of the meeting of Suranaree University of Technology Academic Senate No. 3/2565, dated 24 March B.E. 2565, SUT hereby announces as follows:

Article 1 This Announcement is entitled "Announcement of Suranaree University of Technology on the English Language Assessment for Undergraduate Students of Suranaree University of Technology, B.E. 2565"

Article 2 This Announcement shall come into force upon the date following the issued date.

Article 3 The following announcements are repealed:

Article 4 In this Announcement:

"University" means Suranaree University of Technology

"Institutes" means institutes of Suranaree University of Technoology

"Students" means undergraduate students of Suranaree University of Technology

Article 5 The University shall organize the English language assessment for Students to evaluate their English proficiency based on the Common European Framework of Reference for Languages (CEFR) with proficiency level stated in the enclosure of this Announcement.

Article 6 All Students need to take English language assessment with details as follows:

- 6.1 The newly registered Students of academic year B.E. 2560 onwards need to take the English Placement Test with conditions as follows:
- 6.1.1 Students have the right to report to the University within the first week of the semester the English Placement Test scores in order to be exempted from English language courses. The exempted courses need to be in order with details as follows:

Students have the right to be exempted from the English courses based on their CEFR score level but not exceeding the number of courses stated in the abovementioned table. The exempted courses shall be graded as S and shall be included in the completed credits.

6.1.2 In the case Students do not apply for the exemption right as stated in Article 6.1.1 or do not have such right, enrollment in the English courses according to the general program is required.

6.1.3 The newly registered Students from academic year B.E. 2561 onwards with CEFR test scores at level A2 or above (≥21 scores) are deemed to achieve the English competence standard criteria required for graduation. The Center for Educational Services shall record the CEFR scores prior to Students' graduation and the English language assessment is no longer required.

6.1.4 The current Students with English language assessment scores following the criteria in Article 6.1.1 can report the scores to the Center for Educational Services to be exempted from the English courses which Students have not earned the grades yet. The exempted courses will be graded S.

6.2 The undergraduate students registered at the University from academic year B.E. 2561 onwards need to achieve one of the following English competence standard criteria in order to graduate:

6.3 Students with other English assessment scores than the scores shown in the abovementioned table need to report the scores to the Suranaree University of Technology Academic Senate for consideration on a case-by-case basis.

6.4 Students taking English Placement Test and English Proficiency Exam

for 1 time each need to take and pass the English assessment prior to their graduation. Failure

to pass the assessment leads to retaking the assessment for one more time with free of charge.

Taking the English language testing for more than 4 times will incur the fee.

Article 7 Students can report to the University the other English proficiency test

scores such as TOEFL, TOEIC, IELTS, etc. by referring to the table in the enclosure of this

Announcement in order to be exempted from both the English Placement Test and English

Proficiency Exam organized by the University. Students need to submit the proficiency test scores

and related evidence to the Center for Educational Services within the determined period and

the scores need to not exceed 2 years on the score submission date.

Article 8 The Institute may seek appropriate methods to increase Students' skills

in language and other subjects for Students to acquire improvement in English language skill for

practical use.

Article 9 The Center for Educational Services shall organize the English language

every academic semester.

Article 10 In the event difficulties arisen as a consequence of this Announcement,

the Rector of University shall hold authority to make decision. The decision of the Rector is final.
